CBIR 2020 Funding Update: In November we talked reallocating \$10,000 from the Mentorship program. We were able to reallocate and got approval from EOCCO. We were able to provide funding to the Warming Station, the Oral Care program and the Lactation Support Group. We will need to spend down the funding in March. We will be reaching out to the projects that were funded at the end of January to find out if they will be able to spend down their funding by then or not.

CBIR 2021 Update: We had a subcommittee meeting and spent some time reviewing the applications. We decided we would fund all 8 applications and almost all will be funded at the full amount. We will be filling out the full application and be turning it in by January 15th, 2021. We are advocating for a quicker turn around to receive the funds sooner than we normally do. Oral Care program will receive \$10,000

We will also not be able to fund the CBIR Coordinator this year.
