Discussion	LCAC CBIR Updates- Troy Soenen
	<ul style="list-style-type: none"> ❖ At the time of the transfer from Umatilla County to OWhN (December 2020), the beginning balance of the LCAC Support Funds were \$25,290.81. They now sit at \$21,440.81. Reminder that the Administration Fees for the LCAC CBIR funds need to come out of these funds \$12,500. ❖ Final Reports are due 3.31.2021- Marci will forward the email to Amy for distribution to the sub-grantees. ❖ Reviewing the contingencies for the 2021 funding. Troy thinks that almost everything has been explained by the EOCCO Field Team to alleviate any of the concerns except for the purchase of a vehicle by OWhN. This is still being looked into for other possible alternatives.

Maybe come back to later. ❖ Catie Brenaman (UMCHS)- joined the meeting and stated that she has been completing some forensic accounting with her Finance Department on the CBIR funding. She is comfortable in stating that all the previous year's funds have been depleted as well as the carryover amount is \$34,252. A question was asked as to whether this amount includes the 10% still to be awarded when the final report is accepted. It is not clear at this time whether it includes this amount or not.

- > Heidi Zeigler (DHS)- The Spring Diversity Conference will be held in April and will be recorded. Heidi will send the invite via email to Tiffany for distribution.
- > Vaccination event- 1250 covid doses for Food Processors and Agricultural workers. Must be 16 yoa or older. Need volunteers.
- > Family coaching has started again. Case Managing is back and active, however, no in-person meetings are being held. Employees are reaching out and reconnecting.
- > Jessica Reker (Good Shepherd)- Education Department is changing its name to Community Health & outreach. They have applied/received two grants for rides to Tri-Cities and for denture services (@\$9,600). Walk-in vaccine event coming up, visit the website for more information
- > Catherine Wisniewski (Good Shepherd)- Has submitted a request to utilize UmCo LCAC Training Funds to provide for 3 people to become Tobacco Treatment Specialists at \$3,900 with a \$4,800 in kind match by Good Shepherd to expand efforts. OWhN would like to include 2 people in this training and will commit \$3,250 to cover half of the \$6,500 needed. Motion to utilize \$3,250 of Umatilla County LCAC Training Funds for 5 people (3 GSH, 2 OWhN) to become trained. IF Training Funds are available, use them, if not, utilize Umatilla County LCAC Support Funds to cover this expense. Moved by Amanda, Second by Janet. Motion Approved.

- > Jessica Marcum (Community Paramedic Program)- Program has been in operation for 4 years. They visit patients in the home after they've been discharged and also for those who have high ED usage. They work to meet the individual's medical and social needs. It has been shown to reduce utilization of the ED. They provide Welfare Checks and wraparound care. They are looking for sustainable funding for this program. Amy asked to have Jessica and this program on the agenda for next month for a more complete report on this program.
