## Lake County CHIP/LCAC Minutes

**VISTA Project Updates:** Katie Mannina presented her final Project Overview as this is her last meeting (VISTA service year ending in June). Clara Morris shared the presentation she gave at the RCAC meeting regarding the barriers that Lake County is experiencing with CCO requirements. Clara also heads up our LCAC working group and reported they are developing an action plan to share with RCAC. Lastly, her COVID impact survey is complete and she is processing the results.

**CHIP Updates:** Arvinder Singh was absent and will update at the next meeting.
